**Course: Prehospital Emergency Pharmacology**

**Course Description:** This course focuses on the normal pathophysiology of the systems of the human body, and how these systems are related. The course emphasizes the pathophysiologic changes that occur during common medical emergencies. It also includes treatment modalities based on the pathophysiologic changes.

**Course Objectives:** National Standard Curriculum for Paramedics (DOT Curriculum)

**Assessment Techniques:** Mastery of specific outcome statements will be assessed through class participation, skills tests, written exams, written reports, and oral questioning. The exams will cover material presented and discussed in class, assigned reading material, computer instruction, audiovisual material, and classroom handouts.

**Attendance Policy:** Students are permitted **one unexcused absence in EMT 210, 211, 212, and 213 combined**. More than one unexcused absence will result in a meeting with the Paramedic Coordinator and Program Director. The student may be asked to withdraw from the program or receive a grade of "F".

**Tardiness:** The student is expected to be on time. **Three unexcused tardies will be considered one complete absence**. As stated previously, if a student accrues two absences, they may be asked to voluntarily withdraw from the course or receive a grade of "F".

**Uniforms:** Students are required to wear the clinical uniform to class. Uniforms should be as described in the Program Handbook. If a student fails to wear the clinical uniform to class, they will be dismissed from class and counted absent for that day.

**Grade Values:** The course grade will be calculated as follows:

**Make-up Policy:** All quizzes, exams, and practical evaluations may be made up at the instructor's discretion. If a student must miss an exam, it is **their** responsibility to notify the instructor **PRIOR** to the exam. Notification may be by date/time stamped e-mail for voicemail prior to class start time. Failure to notify the instructor prior to the start of class may result in a failing grade for the exam. Make-up exams must be completed within 7 days of the original exam date. The student is responsible for making up missed assignments and obtaining missed lecture material.

**Academic Misconduct:** Plagiarism, cheating, and other forms of academic dishonesty are **prohibited**. Students guilty of academic misconduct, either directly or indirectly through participation or assistance are immediately responsible to the Instructor and/or the Program Director in addition to other possible disciplinary sanctions which may be imposed through regular institutional procedures. If a student is guilty of misconduct, the Instructor has the right and option to assign an "F" or "0" for the exercise, the examination, or the entire course. This would make the student ineligible for the National registry Exam. The student may also be expelled from the program and/or college at the discretion of the program faculty and/or other academic administrative bodies.
