- Independent borrowers may receive an additional \$4,000 in unsubsidized loan per award year in addition to the freshman/sophomore limits listed above.
- You must complete an on-line Master Promissory Note and Loan Entrance Counseling before loans can be disbursed. This is a one-time obligation at Columbia State Community College. You may complete these steps at [www.studentloans.gov](http://www.studentloans.gov).
- Loans are always divided into two equal disbursements.
- If you are a freshman, first-time Federal Student Loan borrower there is a mandated 30-Day delay on your first disbursement.
