Citizen Ride-Along Rules

1. **You must remain in vehicle during all calls.**
2. **No weapons allowed.**
3. **You must follow instructions at all times.**
4. **No smoking in vehicles.**
5. **You can not speak with or ask questions of anyone involved with an incident or call that you may be on that pertains to the incident, this is the fire fighter's job. Small talk is okay.**
6. **Seat belt must be worn at all times.**
7. **Appropriate clothing must be worn. Blue jeans, khaki-type pants, tee-shirt or polo-type shirt are okay. No shorts, skirts, low cut tops, tank tops, etc. will be allowed. No tee-shirts with designs or markings relating to narcotics, sexual conduct, foul language, etc.**
8. **You must have driver's license on your person at all times.**
9. **No cameras or audio recorders are permitted. Mobile devices that have picture, video, or audio recording capability shall not be used during the ride-along. Pictures with the fire fighter or fire fighter's vehicle are permitted so long as the pictures do not embarrass or degrade the Department.**
10. **Any adult rider must understand that on certain hot calls, the fire fighter may leave you at a safe location in order to respond. Any juvenile rider will remain with the fire fighter at all times, but the fire fighter will not respond to the call until the juvenile rider has been left at the Fire Department.**
11. **The participant may request that the ride-along be terminated at any time. The participant will be returned to the Fire Department as soon as the fire fighter determines it is practical.**

12. The fire fighter or Shift Supervisor may terminate the ride if the participant fails to follow regulations or is acting in a manner inconsistent with the best interests of the Department.
