## **Program and degree information**

Students who successfully complete the planned learning activities in the Nursing Program's curriculum earn the Associate of Applied Science (AAS) degree. The Columbia State Nursing graduate is eligible to apply to the Tennessee State Board of Nursing to sit for the National Council Licensure Examination for Registered Nurses (NCLEX-RN) pending individual approval from the state board of nursing. The Tennessee State Board of Nursing (TBON) provides online information for application and licensure for Nursing in Tennessee.

Students pursuing this program who live outside of Tennessee or plan to move to another state for employment are warned there may be additional requirements needed to obtain licensure or certification in another state. Columbia State has not determined if requirements are met for licensure in all states or territories of the United States. These states are identified as "Does Not Meet" in the table below. Even if identified in the table below as Meets, it is possible requirements have changed since last reviewed. Consult the appropriate state licensing/certification board to determine if the chosen program of study will meet the requirements in the state(s) where you intend to seek employment. Tennessee is a member of the Nurse Licensure Compact (NLC), allowing graduates to apply for multi-state licensure.
