2020-2021 Student Success and Completion Summary – Columbia State continues to maintain fall-to-spring persistence and three-year graduation rates for first-time-freshmen cohorts. There was a slight decline in the fall-to-fall retention rates for 2020 first-time-freshmen, a possible cause for this decline is the COVID-19 pandemic and the change in course delivery methods caused by the pandemic. Momentum indicators reflect early student progression and are considered to be indicative of the completion rates for the respective cohort. The momentum indicators for gateway English courses are 4% below the minimum while gateway math courses are 11% above, however the most concerning is the small percentage of first-time freshmen completing twelve credit hours or more in their first semester of enrollment. The completion of 30 SCH in the first year of enrollment showed improvement this year and may indicate students will meet outcome based funding formula targets in the following semester. Achieving the Dream planned actions of developing academic plans for incoming freshmen should help to combat this unsatisfactory metric.

2020-2021 Quality Summary – The licensure exam pass rates were excellent and should continue to be one of our exemplary measures. Survey results showed a steady rating in the overall Columbia State educational experience. The two academic audit and peer reviews making up the 2.4 score for 2020-2021 were the Film Crew Technical Certificate program and Associate of Science in Teaching program. Unfortunately, due to the additions of several concentrations for the AST program the audit score for this program was lower than expected as the measures had not had time to go beyond the rating of 1 or 2 in the scale of 0 to 3. The College expects these to improve as the concentrations mature.

2020-2021 Access and Equity Summary — Columbia State enrollment levels declined overall in Fall 2020 around five percent. Even during this enrollment decline our dual enrollment, first-time freshmen, and underrepresented minorities continued to stay above the desired baseline. Conversion of students from applied to enrolled during this timeframe was a problem due to the lack of in-person availability during the COVID-19 Pandemic. Columbia State worked very hard to continue student activities as possible in 2020-2021, but some activities were not compatible with the virtual environment. Additionally, it should be noted that Fall 2021 enrollment continued to decline, and the College continues to work to regain pre-COVID enrollment levels.

2021-2022 Access and Equity Summary – Columbia State enrollment levels continued to decline overall in Fall 2021 around ten percent. Even during this enrollment decline our dual enrollment, first-time freshmen, and underrepresented minorities continued to stay above the desired baseline. Conversion of students from applied to enrolled continued to be an issue for Fall 2021, however, in-person availability beginning in May contributed to the slight uptick in these conversion measures. Columbia State offered a variety of course delivery formats in Fall 2021 including on-ground sections during this time of transition.

2020-2021 Resourcefulness Summary -

Columbia State operates traditionally using fiscally conservative principals. This mode of operation has served the College well over the years resulting in operational stability even through times of large cuts in state funding and drops in enrollment allowing us to maintain employment of full-time workers. The college showed continued growth of resources through contributions to the Columbia State Foundation and grant awards in the 2020-2021 fiscal year. This year showed a marked improvement in the Quality Assurance Funding particularly concerning the focus populations and our share of the THEC funding formula which showed an increase from the prior year. One area of in the Outcomes Based Funding Formula for the past year is a continued slight decline in certificates.

2020-2021 Community and Partnerships Summary – Columbia State views the college as a partner with our communities. Metrics showing a decline contact hours through workforce development are reflective of the new requirements for counting hours developed by TBR and THEC. It is disheartening to see the large decrease in the number of new graduates feeling a strong or very strong connection to the college even with the increase in the number of alumni giving to the institution. However we remained the top school selected by 2019 high school graduates of the counties in our service area with the exception of Perry County.
